ORDER

Whereas, the Government in H&UD Department have taken initiatives for introduction of Online Building Plan Approval System (OBPAS) across the state in all Development Authorities and Urban Local Bodies under overall umbrella of SUJOG for streamlining and fast tracking of the building plan approval process.

And whereas, after detailed discussion with all the Planning Members of different Development Authorities within the State, a uniform delegation of power for approval of building plan at different level has been fixed. The aforesaid delegation is based on height of building, plot size and type of building and accordingly, the OBPAS system has been developed incorporating this process of approval.

Therefore, in exercise of powers conferred under sub-section (1) of section 103 of ODA Act, 1982, all the Development Authorities are directed to adopt the uniform delegation of power for approval of building plans as outlined in the table given below for different categories of projects.
